Resolve to institute an automatic rebate function for annual Congress registration.

Executive Summary

WHEREAS, the AARC Board of Directors initially established an automatic rebate function for members registering for the Annual Congress, which was highly effective and member-friendly; WHEREAS, in the previous year, the rebate amount was increased from five to ten dollars, enhancing the benefit to members;

WHEREAS, the implementation of the new rebate process required members to undertake additional steps including locating a checkbox, clicking on the field, and entering a specific code to activate the rebate, which complicates the registration process;

WHEREAS, the complexity of the new process has led to members either forgetting or failing to complete these steps properly, resulting in a financial loss both to the members and their respective state societies, which depend on this revenue for continued operations and support; WHEREAS, the simplicity and effectiveness of the previous automatic rebate functionality proved to be in the best interest of both members and state societies;

RESOLVED, that the AARC Board of Directors is respectfully requested to direct the Executive Office to reinstate the previous automatic rebate functionality for the Annual Congress registration; RESOLVED FURTHER, that by reinstating the automatic functionality, the AARC will enhance member satisfaction, ensure equitable access to the rebate, and support the financial health of state societies, thereby encouraging continued membership and participation in AARC activities.

Desired Outcome

This response to the resolution supports the ongoing commitment of the AARC to maintain and enhance equitable partnerships through co-marketing agreements, ensuring mutual benefits and advancing the interests of both the AARC and its state affiliates.
